Pianta Piano Primo

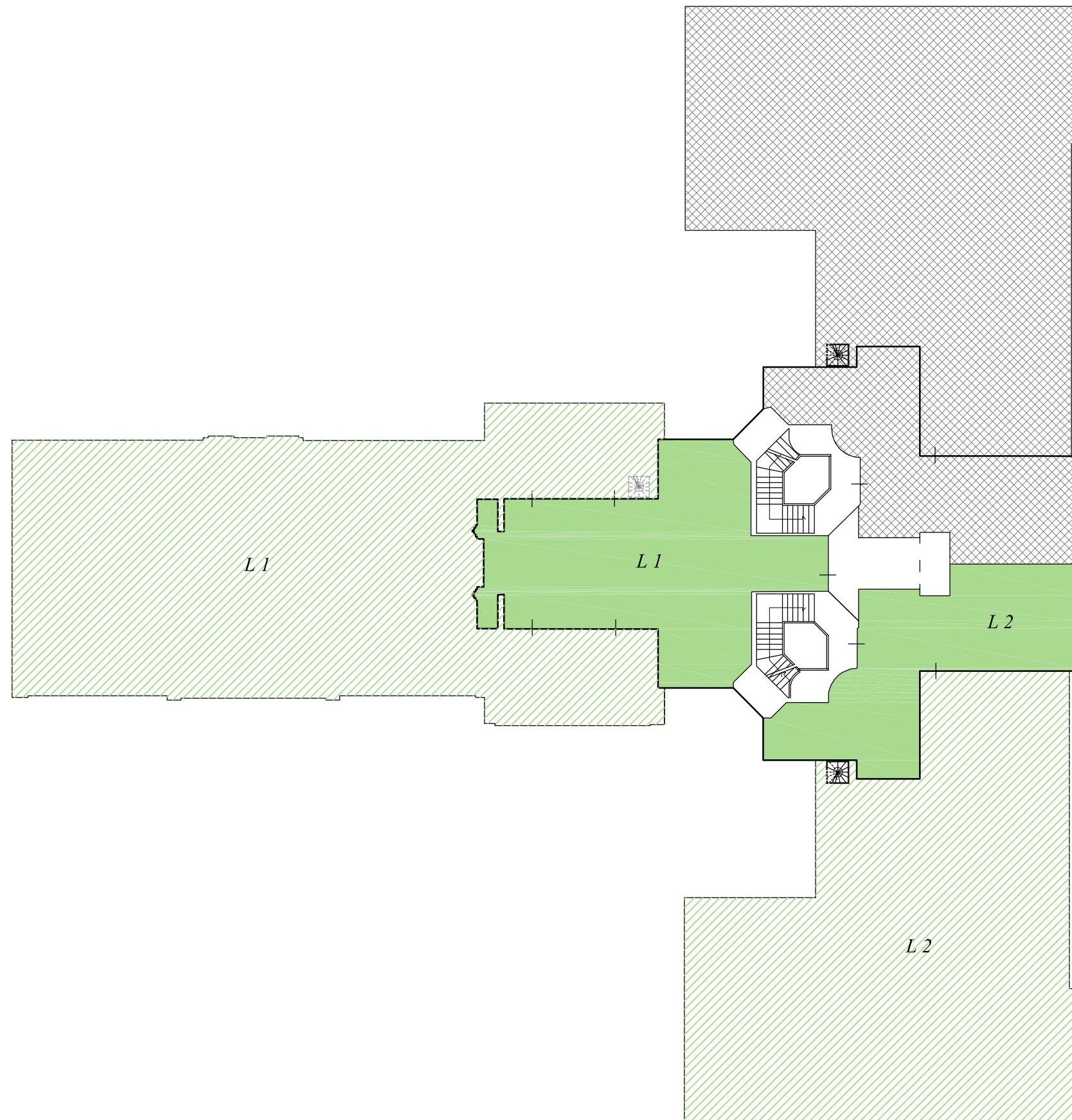





Pianta Piano Secondo

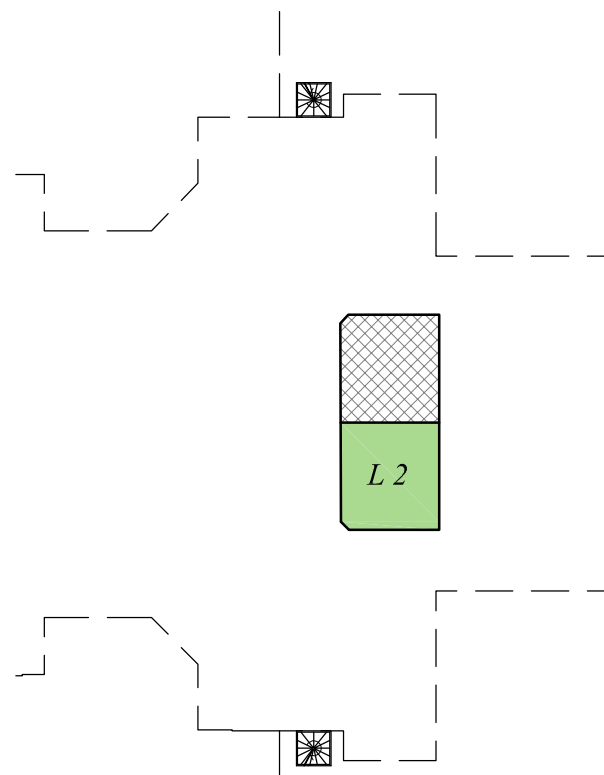





Pianta Piano Terzo

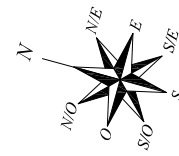
